Volunteer Agreement & Release from Liability

1. As a volunteer for *the City of Aberdeen & Aberdeen Main Street* I agree to work during my scheduled time as agreed. I understand that I will not be compensated for any time spent volunteering, nor am I entitled to benefits, including employment insurance benefits upon the termination of this agreement or because of this service. *The City of Aberdeen & Aberdeen Main Street* may terminate this agreement at any time without prior notice for any reason.
2. I am aware that participation as a volunteer may require periods of standing, lifting, and carrying objects or items (i.e. tables/chairs/boxes) and will require the exercise of reasonable care to avoid injury. I am voluntarily participating in this activity with knowledge of the hazards & potential dangers involved & agree to accept any & all risks of personal injury & property damage.
3. As consideration for volunteering for *The City of Aberdeen & Aberdeen Main Street* , I hereby agree that I, & my assignees, heirs, guardians, legal representatives, will not make a claim against or sue *The City of Aberdeen and/or Aberdeen Main Street* its employees, agents or contractors for injury or damage resulting from the negligence, whether active or passive, or other acts, however caused, by any of its officers, employees, agents, or contractors of *The City of Aberdeen and/or Aberdeen Main Street* as a result of my volunteering. I agree that this release is as broad &

inclusive as permitted by the laws of the State of Maryland. I hereby release & discharge *The City of Aberdeen* & it's officers, employees, agents & contractors from all actions, claims, or demands that I, my heirs, guardians, & legal representatives now have, or may have in the future, for injury or damage resulting from my participation as a volunteer.

4. I understand that if I am injured during my volunteer time, I am not covered by *The City of Aberdeen or Aberdeen Main Street's* workers' compensation program. I authorized to seek emergency medical treatment including x-ray, surgery, hospitalization & medication on my behalf in the case of injury, accident or illness arising from my involvement as a volunteer. I understand that I will be responsible for medical costs incurred by such accident, illness, or injury.
5. I understand that the materials & tools provided by *the City of Aberdeen & Aberdeen Main Street* are and remain the property of *The City of Aberdeen & Aberdeen Main Street*, and I agree to return those tools & any remaining materials to *The City of Aberdeen & Aberdeen Main Street* at the end of my volunteer service. I agree that *The City of Aberdeen & Aberdeen Main Street* is not liable for any damage to my resulting from volunteer service for *The City of Aberdeen & Aberdeen Main Street*.
6. I understand that after I submit my application, it will be reviewed & my eligibility for volunteer work will be determined by the Main Street Coordinator.
7. I certify that my answers on this application are true & complete & that I have not knowingly withheld any information that might, if disclosed, affect my application unfavorably. I understand that any misrepresentation or omission of facts on this application could be cause for rejection of this application or dismissal.
8. I understand that if I am appointed to a committee, I must make every effort to attend the meetings. If I am absent from three meetings in a row, I will automatically be removed.
9. I understand that if I am volunteering, I must make every effort to be present for Main Street events. I understand I should volunteer for at least one every calendar year or I may be automatically removed.

I hereby acknowledge that I have been provided with an opportunity to consult with legal counsel regarding this Release of Liability Form and have not relied on any representations or statements of *The City of Aberdeen & Aberdeen Main Street* and its subsidiaries & affiliates & their respective agents, employees, officers, directors, shareholders, volunteers, personal representatives, successors, & assigns with respect to the subject matter of this Release of Liability Form.
